River Improvement Project

If you like to cycle, walk, jog or travel in a beautiful setting from one side of town to the other, this is for you. A new trail is being developed on city property that has been previously ignored and overlooked. It will run along a ridge on the east side of the Cheboygan River from the footbridge to the back of Great Lakes Tissue, then eventually to Lincoln Avenue. Though construction has just begun, the vision is for a beautiful ADA accessible trail that will include river overlooks, signage, markers, benches and spurs that will allow river access for those who travel by foot.



This revitalization is the brainchild of Dick Sanford, Cheboygan County Community Foundation President Emeritus and board member, who has enlisted others as consultants. As the trail develops, the consultants with more experience and expertise will be called upon. Currently, project leaders Dale & Connie Rieger have led volunteers in flagging and cutting the rough trail and removing some of the dead ash trees that are a visual blight when the property is viewed from Main Street.

Surprisingly, the proposed trail runs through a large number of apple trees and lilacs. When the trail was being flagged the whole area was fragrant with apple and lilac blossoms. It had the feel of a Cheboygan blossom festival.

Cheboygan residents and visitors may have heard the sound of the chain saw as the trail was cut and cleared. Beginning in late August, large tree removal equipment will be heard and seen as trees are cut, moved and chipped to create trail surfacing. This large undertaking will be funded by the Cheboygan County Community Foundation, from local contributions with oversight by Cheboygan City Manager, Tom Eustice.

The trail at this point is rough and in the very beginning stages. It is a project that will extend over three to five years and be completed as funding is available. The final phase of the trail will be ADA accessible. The hope is by fall or early spring 2019 there will be a trail that is open to foot traffic and biking. So stay tuned and for now put your hiking shoes by the door, get your bike tuned up, and be ready to hit the trail!



Grants

2017 witnessed the Foundation's receipt of a number of grant applications. The applications approved by the Board included: \$270 in scholarships for high school students attending the Industrial Arts Institute for introduction to welding; \$700 to Friends of Ottawa Park for children's art projects; \$2500 to Northern Lakes Economic Alliance for its Pitch It Night program; \$1063 to the Farmers Market in Cheboygan for



Cheboygan Farmers Market is held twice weekly during the growing season. banners advertising the Market at several locations in the City; \$1000 to the Cheboygan Youth Academy which teaches leadership to youth in the County through golf; \$266 to Cheboygan Area High School to enable students to attend programs at the Petoskey campus of North Central Michigan College; \$1700 to Voices Without Borders enabling area

high school choir students to participate in a European tour; and \$5000 to Cheboygan Little League to help replace the fence at the girls's softball field. The fence was a requirement which had to be met in order for Cheboygan to qualify for tournaments which bring in hundreds of fans and thousands of dollars. In addition the Foundation, as fiscal agent for the Great Up North Marketing Alliance, contributed \$2500 to the Indian River Chamber of Commerce for its Pure Michigan contribution.

The Board is presently reevaluating its grant criteria to refocus on those applications whose primary purpose is tangible economic benefit. This means grants that demonstrate a real possibility of increased employment, new businesses, or business expansions will be given very favorable treatment.

Port Initiative Update

The Port of Cheboygan continues to move forward as Kokosing/Durocher and Ryba are now operating as Port Operators. Both have "Port Facilities Plans" which includes licensing and permits for the required fencing around the Port area.

The marketing of the Port Facilities has begun. This will include promotion of shipping and receiving, along with attracting manufactures to locate in the Port area and Industrial Park.

The Cheboygan County Community Foundation has contributed \$34,900.00 to the Port initiative in increments since 2011 to enhance the marketing campaign.
